The PIP will seek to put in place a solution to resolve your debt problems, keeping you in your home where it is possible to do so.

A borrower will be eligible for the free advice and assistance if they are:

- insolvent;
- in mortgage arrears on his or her principal private residence, and
- at risk of losing their principal private residence
- in a home that is not disproportionately large for their needs.
